About the Workshop:

The National Research Programme on Plantation Development (NRPPD) at the Centre for Development Studies, in collaboration with Omeo Kumar Das Institute of Social Change and Development and the Department of Geography, Sikkim University, announces its third annual, Seven-day residential research capacity-building workshop on the theme 'Plantation and Development'. The capacity-building programme aims to enhance socio-economic research on plantations in India. The plantation economy in India is undergoing vast changes in its production and consumption with value-added production and niche varieties becoming norms. The estate model of production is giving way to small and marginal growers. Technological change in agricultural practices and marketing is promising more efficient production, while climate change and local weather unpredictability are new challenges on the rise. Livelihoods fully dependent on plantations are becoming challenging. The increasing complexities in the plantation sector need a renewed thrust on research in these areas. This programme would cull out approaches and methods to conduct in-depth research on the issues raised above.

This CBP would include, but not be restricted to, the following themes:

- Theoretical and analytical approaches to understanding the plantation economy
- Quantitative methods for plantation studies, including spatial statistical tools
- Economics of production, marketing and sales
- Institutions and innovations
- International trade in plantations
- Ecological and environmental issues
- Small holders and collective formations, labour and livelihood,
- Plantations and land use, and
- Database on plantations.

Pedagogy would include classroom lectures, workshops, and immersive and interactive learning.

The course is targeted primarily at Social Sciences/Agriculture Science research students and young faculty members of India. The ideal participant in the workshop would have explicitly exhibited her interest in plantation studies through dissertations/articles/presentations/ research proposals/ teaching component that intersects with the topics mentioned above.

The total intake in a batch would be **thirty** (30). Attendance is compulsory throughout the programme.

Course structure:

This is a short-term, full-time residential course for seven days. The course would be conducted from **27 October – 2 November**, 2025. Lectures would be conducted by plantation experts and faculty members from Universities and Research Institutes, other academics and practitioners.

Course Fee (Non-Refundable) for Shortlisted Candidates: ₹ 500/-

Travel and Accommodation: Boarding and Lodging would be provided, free of cost, to the participants. Travel costs would be reimbursed on producing tickets as per rules (AC 3-tier/ bus) and through the shortest possible route.

How to Apply: A completed application form with a statement of purpose (**not less than 1000 words**) and a latest C.V. should be sent on or before **21 September 2025**.

Selection Procedure: Preference would be given to the scholars in their advanced stage of research and young faculty. Selection would be based on the performance of the scholars in their research, such as publications, presentations, etc. and the suitability of the programme to their ongoing and future research. Only selected candidates will be informed through email by the last week of September.

Certificate: On successful completion of the programme, organisers will issue a course completion certificate.
