




# Director's Message




# Programme Coordinator's Message

The MA Programme at the Centre for Development Studies (CDS) focuses on Applied Economics training for its students. The Centre is affiliated to Jawaharlal Nehru University (JNU). CDS has a unique feature and a pluralistic orientation to analysing issues related to economic development. The programme has been built on the strength of three cornerstones - analytical rigour, pluralistic theory and a careful empirical analysis. All faculty at CDS encourage students to focus on understanding history, politics, and context before analysing any issue at hand. Our approach also is enhanced given the fact that the bunch of students to the programme come from all parts of the country and varied socio-economic classes which facilitates an enhanced peer learning among students. The alumni from the programme are spread across various important positions in academia, corporate sector, public sector, not-for-profit organisations, and development sector. The elective courses builds on these basics and offers specialised courses on Development, Labour Economics, Agricultural Economics, Behavioural Economics, Gender, Population, Public Finance, and International Trade. There are also a few courses offered like Economic History and History of Economic Thought which helps students develop a pluralistic method to understanding economic issues. The course also involves the student conducting original research thesis under faculty supervision in the last semester. Apart from these courses, the students can sign up for various certificate courses which are short-term training courses in specific areas of interest. Some of the certificate courses offered in the Centre include Financial Econometrics, R-programming, Advanced Economic Theory, Game Theory, and Ethnography. The regular seminars at the centre involving reputed scholars from various parts of the country and the world also offer some wonderful learning opportunity for the students.

The current batch of MA students (2022-24) is a group of bright young minds who have been hard working during their association with the centre. The students of the batch have shown agility and courage along with us in responding to challenges imposed by the rigorous coursework. They have shown serious commitment to academic rigour. 


# Programme Coordinator's Message

Centre for Development Studies (CDS) is located in the southernmost part of India, but has been continued to be at the centre stage of the Indian academia on Economics and Development Studies. The centre is one of the top ranked places in Economic research of this country. The M.A. program is relatively new in this fifty-one years old internationally reputed research institute, but like other programmes here, this one also successfully carrying forward the legacy of the centre. The programme was started in 2012-13 and has been running commendably since then. This programme is affiliated to Jawaharlal Nehru University (JNU), which is one of the top ranked universities of this country. Along with the regular classes, numerous seminars, webinars, invited lectures, workshops are organised throughout the year where students get the scope to listen to from noted academicians from all over the world, which further augment the intellectual and academic development of the students. Apart from regular academic interactions, students themselves take part in organising cultural programmes, debates, discussions etc., which further adds to their overall development. Additionally, an excellent library and fully wi-fi enabled campus serves as a great support for students to excel. All these features ensure a huge pool of applications from all over the country and from SAARC countries as well. The Centre for Development Studies (CDS) was established as an autonomous social science research institute on 19 October 1970. It was the leadership and vision of Shri C. Achutha Menon, the then Chief Minister of Kerala that led to the creation of several research centres in Kerala in different disciplines related to the development of the State. He was able to persuade legendary development economist Professor K. N. Raj to set up the Centre and provide intellectual leadership. Professor Raj continued to remain the driving force behind all the academic activities of CDS for over two decades. CDS was also fortunate to have Laurie Baker, a radically innovative architect, visualise and design its campus and buildings in a distinctive but cost-effective manner.

The Centre is, perhaps, one of the first educational institutions in the country to follow a democratically decentralised governing structure ensuring complete transparency in administrative and academic matters. The Centre is managed by a Governing Body consisting of eminent academicians, planners as well as administrators. The present Chairman of the Governing Body is Prof. Sudipto Mundle. The current Director is Prof. C. Veeramani. The Governing Body has delegated several of its powers to sub-committees to ensure the smooth day-to-day running of the Centre.

The state-of-the-art CDS library is one of the largest social science libraries in India with over 1,50,000 titles in economics and related disciplines and subscribing to about 400 professional print journals and around 3500 e-journals. The IT wing of the Centre provides technical support to the faculty, students, library and Administration. The fully WI-Fi enabled campus extends to guest house and hostels. CDS has a regular faculty strength of about 20. Further, it has 18 Visiting Professors/Fellows from across the country and abroad and 29 Administrative Staff.

The main activities of the Centre are research, teaching and training. Right from the beginning, a strong all-India character in terms of both faculty and student composition was seen, as well as being very much internationalized, attracting a large number of distinguished academic visitors from abroad. Presently CDS has tie-ups with eleven international institutions, nine national institutions and three institutions at the state level.

Over the past 50 years, CDS has crossed several milestones. During the 1970s, although a large part of academic research conducted at CDS was devoted to issues pertaining to the national economy, it was natural that CDS researchers devoted significant attention to issues pertaining to the economy and society of Kerala. In the mid-1970s, CDS became an institution affiliated to the Indian Council of Social Science Research (ICSSR) and started receiving a part of its core funding from this agency. Right from its inception, CDS emphasised on training of young researchers and launched the MPhil and PhD programmes, recognised by Jawaharlal Nehru University, New Delhi. It also ran a PhD programme affiliated to the University of Kerala.

Over the past decades, CDS has diversified its research into a large number of areas. Some of the topics that received significant attention in the 1970s and 1980s are no longer in vogue, while new areas of research concern have emerged in the field of development studies. It is also worth mentioning that the Centre received prestigious endowment funds from different government agencies to set up dedicated research units in recent years to focus on specific areas like local government, migration and plantation development. Needless to mention, CDS has been attracting sponsored project research funding from several national and international organisations for researching various dimensions of development.

Another major milestone for CDS in recent years is the launch of its MA programme in Applied Economics in 2012. The introduction of the MA programme marked a paradigm shift in CDS academic profile. Faculty members now devote a significant part of their time to teaching courses in this full-fledged programme, over and above their research commitments and research supervision.
